Fire:

 Chief discussed possibility of Board establishing a Hazard pay for April 1-June 1, 2020.

- Chief shared updates of County billing Township for supplies, FEMA reimbursement grant possibility, decontaminating of ambulances with air packs, cost to decontaminate the n95 masks @ \$3.25 each.

We had 1 confirmed COVID-19 case in Wayne Township. Health Director will notify
the chief with an address of an active case in Wayne Township, so our staff are
aware, as well as if our staff have transported a confirmed case.

Roads/Maintenance:

20200408-05: Jason Ritter moved to repair the 3 skylights at the Newtonsville Municipal Building at the estimate of \$1,800 and to allow an additional \$2,000 to repair the 3 furnaces on the roof if needed, by Tecta America.

- Newtonsville Municipal Building roof is original, has exceeded its life. Estimate to replace roof is \$50,000. Trustee Hinners suggested that the Township hold off on replacing while possible, so that we can apply for State Capital Improvement Fund in 2021.
- 8 tons of cold patch have been used.
- Shiloh and Manilla driveway pipes are complete. 5 Cross pipes on Roudebush, 3 on Park and 1 on Bigam are next.
- There is a large, approx. 4-5 ft diameter dead tree on Manilla, in our right of way, Jason B. will get an estimate to have taken down.
- In Newtonsville, there is an issue with the ownership of Liberty Street. The County has on record that Wayne Township owns the 375' of Liberty from Cross Street to JWH Trucking. There is not a record of the Liberty Street from Newtonsville Road that connects to the 2 small alleys off 131/Wright Street. Approx. 800 ft of roadway in very bad shape. There is one driveway off that has a Liberty Road address. Jason B. filled in very large hole by Schaeffer's' since it was so bad.

20200408-06: Jason Ritter moved to purchase a KM 8000 SXDX 4 Ton Hot Box Reclaimer for \$ 19,200.
